Step-by-step instructions and the forms you need to open a Fund of Funds Lp Funds Roth IRA Sections Roth IRA Application:

For investors opening a new Fund of Funds Lp Funds Roth IRA.

The minimum investment for a Roth IRA in A or C share classes is \$1,000 per fund.

Direct Rollover/Direct Transfer Form: For investors transferring assets from an existing non-Roth IRA or Roth IRA into a new Fund of Funds Lp Funds Roth IRA. If you do not have an existing Fund of Funds Lp Roth IRA, you must also complete a Roth IRA Application.

Custodial Account Agreement: Information on the role of the custodian and your rights and restrictions as a Fund of Funds Lp Funds Roth IRA owner.

Disclosure Statement: General information on Roth IRAs. Keep this document for future reference.

Instructions for Roth IRA Application

1. Account Registration: The information entered in this section must be complete and

accurate as it will be supplied to the IRS for tax purposes. Any changes to this information should be relayed to Fund of Funds Lp Funds immediately.

Individual: If you are opening a Roth IRA in your name.
